WHEREAS, a seat on the AJSA Board of Trustees is a prestigious position that should be fulfilled by the finest and most qualified young leaders from within the Simmental breed, and

WHEREAS, many of the recent regional AJSA Board elections have been uncontested, therefore,

Be it RESOLVED that the AJSA Board of Trustees be restructured to include only twelve seats, with one AJSA Trustee seat open in each of the four regional plus two at-large seats available annually, resulting in eight regional Trustees (four per region) and four at-large Trustees on the AJSA Board, and

Be it further RESOLVED that this process be put into place over the next two years, resulting in fourteen seats on the 20022-23 AJSA Board of Trustees, then twelve seats on the 2023-24 AJSA Board of Trustees and beyond, and

Be it further RESOVLED that a maximum of two of the at-large AJSA Trustees be from the same geographical region, and

Be it further RESOVLED that the regional AJSA Trustees be named using the current system in which seventy percent (70%) of the electoral points are based on popular vote and thirty percent (30%) are based on application and interview, and the at-large AJSA Trustees be named through a process to later be determined by the current AJSA Board of Trustees and the ASA Director of Youth Activities.

Change the Rule 3 in the ASA Rules and Bylaws as follows: Strike the "Genetically modified animals shall not be eligible." from existing rules for clones.

Add Rule 4 as follows.

- 4. Approval of the specific Gene Edited Founder to be considered on a case-by-case basis.
 - i. Entities submitting an application for registration of Gene Edited Founders are obligated to notify the ASA when an animal being submitted for registration is the result of gene editing. Entity must provide documentation to validate what allele was introgressed and where in the genome this occurred, and confirm that it is present and functional in the animal that is being submitted for registration.
 - ii. All documentation submitted to and received from the Food and Drug Administration (FDA) and/or United States Department of Agriculture (USDA) must be provided to the ASA.
 - iii. Gene Edited Founder animals must be parent verified to both sire and dam and genomically tested.
 - iv. Part of approval of edits will be investigation into DNA testing for said edit.
 - v. Gene Edited Founder will be indicated on the animal's registration certificate.
 - vi. Designation of the Gene Edited Descendants handled on a case-by-case basis.

Points of discussion:

In January, our DNA test cost increased a small amount across a variety of tests. ASA immediately instituted a price for add-on coat color dilution in January.

The proposed prices keep a 20% margin for genomic, parentage tests, and bundled genetic conditions and 50% on simple traits.

For parentage testing, there are two current options. Historically parentage verification used a technology called microsatellites or STRs. For the past 10 years or more, the preferred parentage test uses SNPs (single nucleotide polymorphisms) for parentage testing. SNP parentage markers are included on the genomic panels and the suggested method for stand-alone testing. However, all animals (parents and progeny) must be completed on the same platform (either SNPs or STRs). When both SNPs and STRs are ordered, ASA has had a policy to only charge for SNP parentage to encourage that technology going forward but would also have to order STRs when sire/dam have only STRs. The current policy is to not charge the member for STRs but Neogen charges the ASA for both the SNPs and the STRs in this instance. The proposed prices in this resolution would offer the STRs at cost when also completing the SNP parentage tests.

Members ordering STRs would also be required to order SNPs to continue to shift to SNP parentage markers for future generations.
