Add Discussion Item #3: The monies (ASA contribution of up to \$30,000) are to be divided equally among the following 8 contests for awards: Cattlemen's Quiz, Calvin Drake Genetic Evaluation Quiz, Public Speaking, Livestock Judging, Sales Talk, Cattle Show, Showmanship, and SPC (note: if 10 placings—ASA's contribution is one half).

Points of Discussion:

1. Reference: A&E Resolution #1 from April 22, 2018.

National Classic Division of Responsibilities with amendments:

Restructure of the financial responsibilities for the National Classics where the ASA will assume all financial liabilities with the exception of awards, hospitality, and any appreciation awards, and that the division of ASA and host state responsibilities schedule is updated. While ASA will mitigate the risk, ASA is willing to incur the extra costs to keep entry fees relatively stable. This will begin with the 2019 National Classic event.

Points of Discussion:

- 1. A&E Committee and Staff will review the host state applications; the facilities recommended (by the host states) will be evaluated the facility must be cost effective.
- 2. Staff will have oversight to negotiate with the host states to manage the financial responsibilities. If no communication from the host state or approval by ASA will result in forfeiting the \$10,000 for decorations and/or the \$30,000 for awards.
- 3. The monies (ASA contribution of up to \$30,000) are to be divided equally among the following 8 contests for awards: Cattlemen's Quiz, Calvin Drake Genetic Evaluation Quiz, Public Speaking, Livestock Judging, Sales Talk, Cattle Show, Showmanship and SPC. (Note: if 10 placings one half allocated).

Resolution #5: To implement an Exhibitors Choice Award for the 4 major PTP shows in the National Show rotation (American Royal, NAILE, National Western Stock Show, and Fort Worth Stock Show).

Points of discussion:

Exhibitors Choice Award Guidelines:

Vote at each of the 4 major shows in the National Show rotation and results decided at the same time as Ring of Champions by adding points.

1 ballot per exhibitor (as entered on entry card) distributed at time of check in.

Vote for 1 bull and/or 1 heifer – no matter percentage or purebred.

Animal must be exhibited at any show where that animal receives a vote.

Voting period would be from time ballots are distributed and will close 30 minutes after last champion selected at each show. (Ballot box will be located at the ASA booth).

Awards and recognition to be similar awards as those received by winners of the Ring of Champions.

Publish standings after each show:

Publish top 5 Exhibitors Choice and top 5 Ring of Champions points in each division after each show.

Moved and seconded in committee.

Resolution #6: To approve the Tennessee Simmental Association's application to host the 2020 AJSA Eastern Regional Classic. Moved and seconded in committee.

Points of discussion:

Breed Improvement, Chairman Took Hook

Discussion:

- Staff continue to work on improving the genomic pipeline.
- Continuing to work on developing an EPD on days on feed, feed intake
- Cow Herd Roundup develop
- Feedlot health
- Gather the PAP field types; collaboration with CSU

Resolution #1: To accept the proposal from the Performance Advocate Program subcommittee to make the following changes to the program. Moved and seconded in committee.

1. In addition to the existing six traits (BW, CE, WW, YW, YHH, Ultrasound/carcass) add the following traits:

Docility, genomic testing on whole birth contemporary group, feed intake, *mature cow weight, *mature cow BCS or HH, genomic test on Cow Herd, udder score, feet/leg score (when available).

- 2. Set a 90% threshold for contemporary groups on each trait.
- 3. Have a two-tier system to qualify. With the above traits, 8/14 traits with 90% of the contemporary group records for the first level and 10/14 for the next level.

Start with 2018 Fall/2019 Spring THE (reports pulled in August 2020).

Points of discussion:

- Increase the traits acknowledged to better represent sought-after records.
- Encourage 90% recording of CG to still capture the majority of the group records but allow for circumstances when records are
 missed.
- Since several of the traits are difficult and/or expensive, set a multi-tier acknowledgement system.
- If a current performance advocate sends in mature cow weights and BCS, they would qualify under this new system.

Breed Improvement continues.

Resolution #2: To move forward with CHR Phase II as proposed allowing staff to work out the details; however, stay within the parameters of cost and not to exceed the existing budget. Moved and seconded in committee.

CHR proposal:

- Continue to accept new herds under 90% rule: low-cost genotyping (\$25) available if members test 90% of their calving-age cows
 - o If members submit mature cow body weights and body condition scores or hip heights from 90% of their calving-age cows, they receive a \$5 credit to their account for each cow reported. Cows must be 18 months of age or older when mature cow measurements are taken to qualify.
 - O Heifers may also be tested at the \$25 price point.
- Offer low-cost genotyping on heifers and new purchases at the going rate (\$25) for members who have completed CHR testing on 90% of their mature cow herd.

Points of discussion:

- 1. 40,198 female genotypes uploaded to Herdbook as of August 8, 2019 with marked increases in Progeny equivalents during this time.
- 2. \$250,000 for credits was initially set aside; \$171,055 remains
- 3. Comparing data submitted in 2016 to the average number of mature cow phenotypes submitted in 2017-2018 (see table):
 - o 330% increase in cow weights
 - o 615% increase in hip heights
 - o 442% increase in body condition scores

This resolution is contingent on final Neogen contract price point.

Note: Continuation of CHR – the samples will still have to be sent to ASA; ASA collects and forwards them to GeneSeek.

Growth & Development, Chairman Mike Forman.

Discussion:

- The financial implications of the proposed STYLE program need to be clearly understood.

Points of Discussion:

Desire to better share the ASA message with those involved in regional sales barns – including owners, managers, auctioneers, and commercial producers.

Directive #3: Direct staff that the Growth and Development committee will conduct a thorough review of the SLA/IGS Rep Reward Program at the end of 2020. Moved and seconded in committee.

Points of Discussion:

• The Superior Livestock Auction/IGS Rep Reward Program is a new approach to encouraging and incentivizing uptake of the IGS Feeder Profit Calculator to SLA reps. As such, the success of the reward program should be reviewed at regular intervals to ensure its effectiveness. *End of 2020 (calendar year 2020)*.

Discussion Points:

If passes Rule II.M.5 will read as:

5. All sires used in an embryo transfer program or whose semen is frozen for the first time for A.I. use and any donor dams placed in embryo transfer for the first time, must be DNA typed at owner's expense. The results must be filed with the Association prior to the distribution of semen or the performing of any embryo transplant procedures registration of the resulting calf.
