Agenda. Moved Fred Schuetze second Tom Hook to approve the agenda as presented. Motion carried.

ASA Board Meeting called to vote on resolutions and directives from the Executive Committee, Policy & Procedures, and Activities and Events. All resolutions and directives were sent to the ASA Board on February 25, 2020.

Executive Committee

Resolution #1: Foundation Bylaws

Article 6, Section I: The Foundation shall have one (1) officer, which shall be a Chairperson. The Chairperson shall be appointed by the Chairperson of the Association Board of Trustees with the approval of upon majority vote of the Executive Committee. A trustee of the Foundation or a director, officer, or trustee of the Association may service as Chairperson of the Foundation.

Points of Discussion:

Reword Article 6 Section I to include: with the approval of upon majority vote of the Executive Committee when selecting a Foundation Board Chairperson.

Resolution #2: Foundation Liaison

Approve a liaison between the Executive Committee and the Foundation Board. For 2020, Fred Scheutze.

Directive #1

Resolution #7:

To include in the Host Association Duties Judges section: "An Associate Judge is mandatory at the four major shows, NWSS Pen Show, AJSA National Classic Owned Show, and the AJSA National Classic Bred and Owned Show."

To now read as:

"By April 1, submit three (3) names in order of preference from the approved PTP Judges list for consideration by the Activities & Events Committee of the ASA Board. Full responsibility for payment of the lead judge, unless otherwise arranged with show management. Coordinate with lead judge the selection of associate judge and ensure the associate is in good standing with ASA. An associate judge is mandatory at the four major shows, NWSS Pen Show, AJSA National Classic Owned Show, and the

National Classic Bred and Owned Show. Once a judge has officiated any of the four major shows listed above that judge is not eligible to be nominated for any of these events the following show season. " Moved Jim Ligon second Barry Wesner to add lead before judge in the sentence: Once a judge has officiated any of the four major shows listed above that judge is not eligible to be nominated for any of these events the following show season and state: the Associate Judge does not have to be approved by the Activities and Events Committee.

Amended A&E Resolution #7

Judges

Host State Responsibilities:

By April 1, submit 3 names in order of preference from the PTP approved judges' list for consideration by the Activities and Events Committee. Full responsibility for lead judge payment unless otherwise arranged with stock show staff. Once a lead judge has officiated one of the above 4 major shows, NWSS Pen Show, or the AJSA National Classic that lead judge will not be allowed to be nominated the following show season. Coordinates with lead judge the selection of association judge (mandatory) and ensures that the associate judge selection is a person in good standing with the ASA.

ASA Responsibilities:

Activities and Events Committee to make final judge selection (all major show judge selections to be made no later than the April board meeting and secure immediately thereafter). Full responsibility for associate judge payment. The associate judge does not have to be approved by the Activities and Events Committee.

Motion carried.
